

Terms & Conditions, Warranty and Limitations for Products and Services

Stanlok Terms & Conditions

Attention: Purchasing and Accounts Payable Departments

- 1. Minimum domestic order is USD \$50.00, minimum international order is USD \$100.00
- 2. Payment terms are net 30 days, no cash discounts are provided or may be taken
- 3. We accept VISA and MASTERCARD charges. All Credit Card payments are subject to a 3% processing fee added to the invoice
- 4. We do not ship C.O.D, we do not accept personal checks
- 5. International orders are subject to a 30% payment of total order value, due at time of order, balance due at export date
- 6. All orders are shipped F.O.B. from Waukesha, WI 53186
- 7. We ship orders the best way unless specific shipping instructions are provided
- 8. Prepaid UPS shipments will include a 20% handling charge, minimum of USD \$5.00
- 9. Prices and price lists are subject to change without notice, pricing errors are subject to correction
- 10. Lead times for delivery are best estimates and are subject to change
- 11. We do not accept penalties or charges for early or late delivery
- 12. Quantity delivered for non-stock items may be +/- 10% of the original order quantity
- 13. Exact quantities for non-stock items to be quoted at a higher price
- 14. Quoted pricing and delivery lead times are valid for 15 days
- 15. Claims, for any reason, must be made within 30 days of receipt of goods
- 16. Returns for stocked items may be requested within 30 days of receipt of goods
- 17. Return Goods Authorization (RGA) is required to return stock items
- 18. 30% re-stocking charge is applied to all returned stock goods
- 19. Non-stock, special, or make-to-order items may not be returned
- 20. Stanlok Limited Warranty applies to all stock, non-stock, custom manufactured, and distributed items
- 21. Stanlok does not accept purchasing company terms and conditions that conflict with our Limited Warranty

Warranty and Limitations for Products and Services

Definitions

Seller is defined as Stanlok Corporation.

Buyer is defined as any person or entity purchasing goods or services from Seller.

This statement of Warranty and Limitations from Stanlok Corporation supersedes any terms and conditions submitted with, or attached to, Buyer purchase orders.

Warranty

Seller warrants that all goods manufactured or distributed by Seller will be free from defects in materials and manufacturing for a period not to exceed twelve months. This Warranty does not include the misuse, negligence, faulty installation, accident, or modification of Seller products by the Buyer, or by any third party, on behalf of the Buyer. If Seller agrees to a concern of nonconformity of the supplied goods, Seller will have the exclusive decision to repair, rework, or replace the supplied goods. This remedy shall be the sole remedy for any breach of Warranty.

Warranty Limitations

The liability of the Seller shall be limited to the amount of the individual purchase order. In no event shall the liability of the Seller extend beyond replacement, repair, or the issuance of credit for the purchase price of the goods, from the original purchase order. Seller shall not have any liability for loss of time, cost of labor expended, or for any separate, special, direct, indirect, consequential, or incidental damage. No claim by Buyer for goods delivered, or for non-delivery, shall be greater than the purchase price of the goods, from the original purchase order.
